Board of Directors Update

Annual Meeting

President's Report—Jim DePerno

Your board along with Ed Dzioba is charged with the responsibility of managing the business and affairs of the MOH Association. I am pleased to report the state of the Meadows of Highland is good! At this time, financially we are in a good position. We have no debt and our reserve stands at \$255,000. We continue to very carefully monitor and control expenses.

The board, after a careful analysis of the facility found it necessary to increase the monthly maintenance assessment by \$24 per month due to increased costs, the age of the facility and the need to adequately fund future reserve study requirements.

During 2018 we encountered a few major non-budgeted expenses; namely a law suite defense which was filed by Merrill Trefzer, a few water-line water breaks, and a insurance claim which resulted in being over budget by \$21,000.

Projects completed in 2018:

- Water line repairs
- Pond issues: Compliance with EPA mandates (grass carp, microbes, oxygen compressor)
- Installation of new windows and sliding glass doors in the clubhouse
- Replace damaged over head door for garage (hit and run)
- Lamp post replacements
- Continuing tree removals and replacements

Projects planned for 2019:

- Pond dredging assessment
- Garage Roof replacements
- Reserve study update
- Sealing of phase 1 & 3 parking and drive areas



The left sidebar has a list of pages; click on the Member Registration Page.


Fill in required fields and create your own username and password; then click REGISTER.

Origin of Thanksgiving in the United States

The first Thanksgiving of the newly formed United States of America occurred when General George Washington proclaimed a "Thanksgiving" in December of 1977 as a victory celebration honoring the defeat of the British at Saratoga.

Washington's first proclamation after his presidential inauguration was to declare November 26, 1789, as a national day of "thanksgiving and prayer". President John Adams made similar thanksgiving declarations in 1798 and 1799 as did President James Madison in 1815.

During the middle of the Civil War, prompted by a series of articles written by Sarah Josepha Hale, President Abraham Lincoln proclaimed a national day of thanksgiving to be celebrated on the final Thursday in November of 1863. Since which time, Thanksgiving has been observed annually in the United States of America.

Traditionally it was considered inappropriate to advertise goods for Christmas until after Thanksgiving. In 1939 with the country in the midst of The Great Depression, President Franklin Roosevelt reasoned that if given a longer period to sell goods before Christmas, merchants could increase profits and spending during this time. In an effort to help bring the country out of The Great Depression, Roosevelt declared that Thanksgiving should be celebrated on the second to the last Thursday of November instead of the last.

Roosevelt's declaration was not mandatory; twenty-three states went along with this recommendation and twenty two did not. Other states could not decide and took both weeks as government holidays. Roosevelt continued his effort in 1940 to celebrate his "Franksgiving" as it was termed. In 1941, Congress split the difference and established that the Thanksgiving would occur annually on the fourth Thursday of November, which was sometimes the last Thursday and sometimes the next to last.
